II. Following are the terms of membership to the DoubleGate Swim & Tennis Club for families that live outside of the DoubleGate subdivision (a “B” membership):

1. The annual “B” membership fee is \$815.00 for the period from May 1<sup>st</sup> of the current year to April 30<sup>th</sup> of the following year. Please note that the membership fee may be subject to change by the Board of Directors of the Club.
2. Any member who does not pay their membership fee on time will be assessed a 10% late fee. Members who have not paid within 30 days of the due date will be deemed inactive and their membership will be terminated. The annual membership fee for new members for the membership year in which they initially join will be assessed on a prorated basis (monthly) and must be paid with this application.
3. The “B” memberships shall be initially restricted to 25 member families to be reviewed and revised annually as deemed by the Board of Directors of the Club. “B” memberships shall be available on a first-in, last-out basis. (For example: If the current “B” membership limit is at 25 and the Board of Directors of the Club chooses to lower the “B” membership limit to 20 then the last “B” members to join would *not* have their memberships renewed the following year). A waiting list will be established for those wishing to join beyond the determined “B” membership limit.

4. Refunds of the annual membership fee will be provided in accordance with the following policy:
  - A. If the "B" member moves out of the area within six (6) months (May 1<sup>st</sup> – October 31<sup>st</sup>) of the start of the membership year then one-half of the annual membership fee is refundable. After October 31<sup>st</sup> no refund is available
  - B. The Club has the right to hold this refund until your membership has been replaced by a new member and the Board has reviewed the financial condition of the Club and its ability to make this payment. Every effort will be made to return these monies as soon as possible.
5. "B" memberships are non-transferable.
6. Neither "B" members or their guests shall hold the Club or the DoubleGate subdivision liable for any damages or injuries incurred.
7. The "B" member will be fully responsible for any damage incurred to the facilities by himself, his family members, or any guest they may have.
8. "B" membership shall be a non-voting membership but shall retain full rights to the use of all club facilities and club functions.
9. Applicant understands that they shall have no beneficial interest in the properties of the Club but only the privilege of using and enjoying the Club's facilities.

Payment of the annual membership fee must be submitted by check made payable to DoubleGate Swim and Tennis Club, Inc. Payment must be made in full (no partial payments). This check, along with this completed Non-Resident Membership Application should be mailed or delivered to:
